## **Results of the committees' work**

### **Committee on Tourism and Hospitality**

By the initiative of the AEB member "MPS-Hotel" and the leading restaurateurs in Belarus the assortment list of catering products and goods for restaurants, cafes and bars was significantly (2-3 times) simplified and reduced.

AEB Proposals for the **abolition of visas and the establishment of preferential regimes for tourism and hospitality entities** were sent to all key ministries and agencies, placed in the media and presented at :

The Ministry of Education supported the initiative of the AEB members to expand the scope of JSD and offered to develop jointly a mechanism of "the Day of following a professional by a shadow" in 2017 taking into account requirements of national legislation and business interests.

## **Plant Protection Products Committee :**

- Proposals of the AEB members were included in the new edition of the Law on plant protection products
- Appeal from the AEB contributed to postpone adoption of the draft Decree on licensing the wholesale of plant protection products
- The inclusion of representatives of the AEB members in the working group in the Chamber on the preparation of the draft Law for 2017
- Appeal "on the consequences of changes in the legal regulation in the sphere of purchases of plant protection products" was directed to the Presidential Administration, the Council of Ministers, the Ministry of Agriculture and Food, the Ministry of Economy, the Ministry of Antimonopoly Regulation and Trade and regional executive committees.

## **Taxation committee**

The following officially initiated suggestions :

1) On standardized and monochrome packaging for tobacco products to the Directorate for the regulation of tobacco products in the Ministry of Health of Canada

### **Taxation committee**

3) Appeal to the Ministry of Economy of the Republic of Belarus to amend the work plan for 2017 of the working group on improvement of doing business in the territory of the Republic of Belarus under the Foreign Investment Advisory Council under the Council of Ministers of the Republic of Belarus on:

- adjustment of the Project of establishing quotas for the production of tobacco products, in particular the abolition of the quota system for filter cigarettes of the 1st price group;
- ensuring uniform distribution of the excise burden on cigarettes of different price groups;
- ensuring public access to statistical information on tobacco products and quotas for tobacco production.

JTI with the support of the AEB has organized a seminar for specialists from government authorities about the current trends in tobacco market in the world and Belarus.

# Changes in the legislation on the basis of grant projects implemented in 2016

Amendments dated 10.05.2016, in the Decree of the Council of Ministers of the Republic of Belarus dated March 20, 2012 N 247 "On organization of public discussion of draft laws and regulations on the development of business ...".

Decree is supplemented by provisions on the rights and responsibilities of the board members.

Not only draft regulations developed by the state authority, but also problems arising from legal entities and individuals in doing business can be submitted for consideration and discussion.

Enlarged list of possible boards' members: individuals can be included in the board - experts and professionals specializing in specific sectors of the economy and law.

Republican state administration bodies and other state organizations are obliged to place on their official websites on the Internet and (or) in the media:

- notifications about development of normative legal acts;
- draft normative legal acts.

### **Current ITA grant projects 2016-2017**

### Pilot project on integrated waste management of dairy enterprises

(donor – EU, coordinator – UNDP, AEB budget 2016-2017 – around 11 mil. USD)

- a new partner JSC "Milkavita" milk holding
- refitting a shop floor at the Polesie production site of JSC "Milkavita" (Khoiniki)
- further processing 50 tons per day of whey with high content of the curd mass, which is more active with respect to the external environment and is not recycled by a processing method
- production of a new import-substituting product "whey-fat blend with fat content of 30-40%"

Белорусские предприниматели добиваются отмены протекционистских мер, мешающих развитию бизнеса. Один из таких барьеров – обязательные ассортиментные перечни продуктов белорусского производства, которые должны быть в ресторанах, кафе и других объектах.

Такие перечни серьезно осложняют жизнь рестораторам. Например, иностранному инвестору, рассматривающему возможности вложения средств в белорусский общепит, трудно объяснить, зачем закупать 54 наименования белорусского алкоголя для бара класса люкс. Ещё сложнее убедить его, что Беларусь, не располагая собственными виноградниками, производит вина, коньяки и шампанское, которые достойно представят заведение клиентам.

Чтобы повысить качество услуг, уровень ценовой и географической доступности общепита и диверсифицировать услуги, государство решило посоветоваться с бизнесом. Распоряжением премьер-министра от 5.05.2016 № 168р была создана межведомственная рабочая группа для выработки предложений по совершенствованию организации общественного питания.

Благодаря инициативе ООО «МПС-Отель» (Renaissance Minsk Hotel), члена комитета Ассоциации европейского бизнеса (AEБ) по развитию инфраструктуры в сфере туризма и гостеприимства, были разработаны и направлены в Министерство антимонопольного регулирования и торговли предложения по устранению барьеров для ведения бизнеса в сфере общественного питания. Одно из них – требование отменить ассортиментные перечни продуктов белорусского производства, обязательные для закупки объектами общепит. Предприниматели считают, что рестораны и кафе должны иметь право свободно выбирать поставщика товаров, независимо от места их производства, как это делается во всех европейских странах. По мнению AEБ, устранение перечня плодотворно


